He began Rowe Insurance Agency in 1990 retiring in 1996 when his daughter Laura Harris took over the family business. Mr. Rowe was a member of Easton Wing Civil Air Patrol and also had a commercial pilot's license. He was a member of St Luke's Methodist Church, Denton, MD and the Greensboro Lions Club. He enjoyed traveling, fishing and trap shooting.
